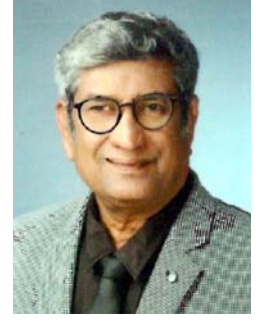



The current covid-19 situation is worrying and has impacted all of us in a significant manner.



## ELECTION CIRCULAR

(A) : Only those permanent members, who have cleared their bills upto Sep, 2021 are eligible to vote. Temporary, Corporate, Service, Associate and Honorary Members are **not eligible** to vote.

(B) :

1. As per the Articles of Association "Spouse of deceased permanent Member" who is inducted is eligible to vote.
2. Members are requested to check the Notice Board for arrears list before collecting the ballot paper.
3. Payment of arrears on or after 15 November 2021 shall be accepted only by Cash/DD.  
All spot payments will be paid at the office only. No spot payments at the place where election is conducted.
4. Members should collect "No Dues" Slip at the office and submit the same to collect ballot paper.
5. **Ballot Paper will not be given unless members produce their ID Cards and NO dues slip.**
6. Club **Senior Citizens** will be given priority to vote.
7. All Members are requested to co-operate in all matters to ensure the safety of all its members by following the **Covid-19 MHA guidelines as announced by the Government of India strictly.**
8. Voting Hall duly sanitized with tables & Chairs placed following the social distancing protocol.
