




Rare Disease Day in India: Raising Awareness and Advocating for Change

VOTE ON ACCOUNT – BUDGET 2024-25

*By the time this article is published, the budget will have been presented in the parliament by Honourable. Finance Minister, Mrs. Nirmala Sitaraman, but the purpose of this article is to provide insight on what a budget is about.

Vote on Account

The uniqueness of this year's budget to be presented by the Honourable Finance Minister Smt. Nirmala Sitharaman is that it is a **Vote on Account**. So what does that mean?

Government, towards the end of the fiscal year or the end of their term, always needs some funds to expand in various vital areas, which cannot wait until the formation of the next government is definition of what is **Vote on the account**.

To provide various essential facilities, the government may take a formality type permission from the Lok Sabha to expend the funds from the consolidated funds of India for two months(or in some exceptional cases, it gets to four). The passing of a good bill will take time, so the Vote on account is done through an interim budget to extend that time until the formation of a new government.

Vote on the account is a formality done by the ruling government by taking permission of the Lok Sabha to spend some funds from the consolidated funds to fulfil the essential need of the citizens. It is practiced by the government of India when the ruling



government does not have time to pass a whole budget. Many financial experts state that the meaning of Vote on the account is based on the formality and is important for the smooth working of the schemes and subsidies provided to the citizen while the new government comes and presents its budget.

What is the role of Vote on account in the interim or final budget?

In a year when national elections are happening, the government doesn't present a full budget but releases an interim budget instead. The upcoming budget by Finance Minister, Mrs. Nirmala Sitharaman on February 1, 2024, will be interim, as general elections are expected in March-May 2024. An outgoing government presents an interim budget or requests a vote on account, leaving the full budget for the next government.

A vote on account formality cannot proceed in the Lok Sabha unless the ruling government does not present the whole budget or the interim budget.

According to the Constitution, the government can't withdraw money from the Consolidated Fund of India (CFI) without proper legal approval. An appropriation bill is usually passed during the budget process for this, which might take time. However, the government needs permission to spend money from April 1 when the new financial year begins.

A Vote on Account is the permission sought by the government to withdraw.

The role of Voting on account while presenting the budget is such that if the interim budget for the few months left for the ruling government fails to get approval and government is left with no consolidated funds to spend on the working of the essential items of the nation, then some funds from the CFI will be approved to the ruling government to expand in some of the areas they want. Providing the ruling government with some funds is essential so that the nation's economic growth does not stop.

Last time a Vote on Account was proposed by our Hon. Finance Minister, Mrs. Nirmala Sitaraman on 11th of February, 2019 for the fiscal year 2018-19.

Budget – Definition

A brief introduction of Budget preparation and presentation to the parliament outlined as follows:

The word "budget" comes from the French word "bougette", which means "small leather bag". Over time, "budget" began to refer to a type of folio containing important paperwork. Eventually, the word simply referred to the paperwork within the folio, rather than the folio itself.

According to Article 112 of the Indian Constitution, the Union Budget of a year, also referred to as the annual financial statement, is a statement of the estimated receipts and expenditures of the government for that particular year. It keepsaccount of the government finances for the fiscal year from 1stApril to 31st March.

A well-constructed budget guides allocating funds to different priorities, such as essential expenses, savings, and discretionary spending. It helps ensure that financial resources are used efficiently and that there's a clear understanding of where the money is coming from and where it's going.

In a professional context, a budget is a strategic tool that aids in decision-making, resource allocation, and financial control. It enables individuals and businesses to set financial goals, monitor progress, and make adjustments as needed to achieve financial stability and meet objectives.

Classification:

An union budget is classified into Revenue Budget and Capital Budget, Union Budget, Revenue Budget.

Revenue budget includes the government's revenue receipts and expenditure. There are two kinds of revenue receipts - tax and non-tax revenue. Revenue expenditure is the expenditure incurred on day to day functioning of the government and on various services offered to citizens. If revenue expenditure exceeds revenue receipts, the government incurs a **revenue deficit**.

Capital Budget

Capital Budget includes capital receipts and payments of the government. Loans from public, foreign governments and RBI form a major part of the government's capital receipts. Capital expenditure is the expenditure on development of machinery, equipment, building, health facilities, education etc. **Fiscal deficit** is incurred when the government's total expenditure exceeds its total revenue

The budget is presented in two parts. Part A deals with the General Economic survey of the country while Part B deals with the taxation. However, the budget for the Indian Railways is separately presented in the Parliament.

Steps involved in preparation of the budget

The preparation for the budget begins way back in the month of September, to be presented in February, which needs to be passed in both houses of the Parliament before 1st of April.

The Indian Union Budget is prepared by the Ministry of Finance in consultation with Niti Aayog and other concerned ministries. Also, the Budget division of the department of economic affairs (DEA) in the finance ministry is the nodal body responsible for producing the Budget.

Finally union budget is presented by Finance Minister in Parliament after an approval by the President.



Waltair's tryst with Cricket.

In Feb 2024, the second cricket Test between India and England was played nearby at the Dr YSR ACA VDCA Stadium. It is interesting to note that the Waltair Club members kept the game at the forefront of the Vizag sporting scene in earlier years.

The earliest record of a cricket match in Vizag was in 1874, when the 7th Madras Infantry arrived at their new posting in the Fort and established a rivalry with the existing Godavari Volunteer Rifles (later the Vizagapatam Volunteer Rifles and in 1917 called the East Coast Battalion, the foundation institution of the Waltair Club in 1883). Their parade ground was the maidan opposite St Aloysius School and this was the venue for their favourite pastime - cricket!

In the mid 1800's, cricket was a professional sport only played in England and there were no international tests. Arthur Luard was born at Waltair in 1861, the son of Colonel GF Luard of the East Coast Battalion. Luard played county cricket for Gloucestershire, Kent & Middlesex and for the MCC team from 1893 to 1907 making him the earliest First-Class cricketer from Waltair.

First records of Ladies playing cricket relate to members of the Waltair Club participating in a social cricket match against the men in October 1888. The Madras Mail reported that the men played with the handicap of batting left-handed with broomsticks and also bowled and fielded left-handed. The match was unfinished, but the Ladies were reported to have been favorably placed for a win.

Maharajkumar of Vizianagram or Vizzy, was an Indian cricketer, cricket administrator and politician who organized his own cricket team, the Vizianagram XI, financially sponsored the game and constructed a ground in his Vizianagram palace compound. Annual cricket tournaments between Vizianagram and Waltair Club followed. Vizzy was named the captain of the Indian team that toured England in 1936. Vizzy and was knighted by King Edward VIII in the King's Birthday Honours. He was a member of the Waltair Club, was the President of BCCI from 1954-1957, was awarded the Padma Bhushan, in 1958, and was a member of the Lok Sabha from Visakhapatnam in 1960 and 1962. In the early years, the first Test captains of India were from Andhra - C. K. Nayudu, then Vizzy and after them Ghulatri (Ghulam) Ahmed, the third Andhra and India's tenth captain. Later, Mohammed Azharuddin was to become the fourth captain of India from Andhra.



Fans of Indian cricket, especially those from Waltair were particularly proud to see Vizag host its first Test, India and England, at the new ACA-VDCA Cricket Stadium on 16 November 2016. It was the first day of play when a dubious piece of international cricket history was created. The India team was


batting, the English bowlers were being punished, Cheteshwar Pujara and skipper Virat Kohli were batting fluently on 97 and 91 respectively, having strung together a solid 188-run unbeaten stand for the third wicket to put the hosts in firm control of the proceedings, before a canine decided to pay the players a little visit at the centre. Play was stopped, groundsmen chased and threw their chappals, and much to the delight of the local fans - the dog continued to run around the field and bring play to a halt. Match officials called for an early tea, and commentators were at a loss for words. Fans from around the world obliged with on-line comments:

'The Dog has been on the field longer than KL Rahul' said one, 'This dog is faster between the wickets than Pujara & Kohli' commented another, and 'Dog outperforms England in superb pre-tea spell' was a suggested by-line. And when the street dogs met that night, the joke could have been... that a dog like them was the only one who could remove Kohli and Pujara from the crease...

Cricket in Waltair has come a long way since those early days, and fans can now be entertained to a full schedule of men and women's cricket, Indian Premier League, Ranji Trophy, One-Day Internationals, International Test series and constant live TV coverage on ultra-high-definition colour screens together with on-line commentary and score updates on flat screen devices. Howzat!
